### [Association of Cannabis Use During Adolescence with Neurodevelopment](#)

In a cohort study from 799 participants ages 14-19, results showed that there is accelerated age-related cortical thinning with cannabis use. The left prefrontal cortex and right prefrontal cortex showed thinning at the 5 year follow up in a dose-dependent fashion (greater cannabis use was associated with greater thinning).
